MEMORANDUM FOR ALL REGION AND WING COMMANDERS

SUBJECT: CAP Driving Privilege Renewals During COVID-19

1. The COVID-19 public health emergency has impacted how states are accommodating driver's license renewals. Considering these changes, we are providing you with guidance on how to renew your CAP driving privileges in accordance with CAPR 77-1, *Operation and Maintenance of Civil Air Patrol Vehicles*.
2. There is a wide range of actions that states are taking in handling the expiration of state driver's licenses. To minimize mission impact, the following guidance is offered for extending or renewing members' CAP driving privileges. Please refer to the attached document for a listing of each states' processes for renewing driver's licenses.
 - a. If possible, the member will renew their driver's license according to their state's guidance. Once the state license is renewed then CAP driving privileges can be renewed per normal CAPR 77-1 processes.
 - b. The approach in some states is to extend the driver's license expiration date. In these cases, the member's approving authority, as detailed in CAPR 77-1, can extend the member's CAP driving privileges to the same expiration date as the member's state driver's license.
3. If operating CAP vehicles in other states, members who fall under the category detailed in paragraph 2b above should carry a copy of their state's license renewal guidance with them. This written documentation could be helpful to local law enforcement officials in the event of a traffic stop or mishap.
4. This guidance is effective immediately for all holders of CAP driving privileges and will remain in effect until corresponding state driver's license issuing offices resume normal operations.
